

# Online Privacy Policy for <a href="https://asego.in/">https://asego.in/</a>

### **Overview:**

Asego is committed to protecting your privacy and working towards offering you a powerful, safe, online experience. To avail some of the services offered by Asego, you need to sign up by giving simple details that personally identify you. Asego needs this minimal information to operate the online services.

This privacy policy is only applicable to the website <a href="https://asego.in">https://asego.in</a>. This privacy policy applies only to the collection, use and sharing of information you provide online.

Our Online Privacy Policy describes the information we collect from and about you during your visit to our website and how we use the information about you, whom we share it with and how we protect it.

Our website may contain links to third party websites not controlled by Asego or covered by this Online Privacy Policy. We recommend that you check the privacy statement of other websites you visit before providing any personal information.

#### Personal information we collect:

As a general rule, this website does not collect personal information about you when you visit the website automatically. You can generally visit the website without revealing personal information, unless you choose to provide such information. The level of information gathered by www.travel.asego.in varies depending upon the user's request. # Use of personal information collected:

We treat your personal information as private and confidential and do not check, edit, or reveal it to any third parties except as herein provided and where we believe in good faith, such action is necessary to comply with the applicable legal and regulatory processes, or to protect and defend the rights of other users or to enforce the terms of service which are binding on all the users of <a href="https://asego.in">https://asego.in</a>

We use the personal information we collect online to process your request for services, policies, products and to amend or modify the policy, products availed by you in future on your requests. We restrict the access to personal information about you to those individuals, such as our employees and agents, who provide you with our services, policies and products.

We may also share your personal information we collect about you with third parties such as companies with whom we have formal agreements for performing services on our behalf to provide the services, products or policies you have requested. We maintain physical, electronic and procedural safeguards that comply with applicable regulatory standards to guard your personal information.

We may disclose your personal information as otherwise permitted or required by law.

We notify that the information you provide to <a href="https://asego.in">https://asego.in</a> may be stored in a country other than where you reside.

### **Cookies:**

Users are also made aware that certain information and data may be automatically collected through the standard operation of our internet servers or through the use of "cookies." "Cookies" is a term generally used for small text files a website can use to recognize repeat users, facilitate the user's ongoing access to and use of the website, allow a website to track usage behaviour and compile aggregate data that will allow content improvements and targeted advertising etc. Cookies themselves do not personally identify you, but they do identify your computer. Generally, cookies work by assigning a unique number to the user computer that has no meaning outside the assigning website. You have the option to reset your browser to control cookies; however, some of the services offered by the website services may not function properly if cookies are refused.
